**Section 3 - General Rules and Regulations**

1. All food vendors must have a valid Livingston County Health Department Permit/Certificate. Inspections will be made during the event.
2. Vendors must comply with fire department regulations. Inspections may occur.
3. Vendors should carry the appropriate insurance for the event.
4. Location will be assigned by the Rodeo Committee. Once assigned, changes will not be permitted.
5. For insurance reasons, motorized vehicles are not allowed to be used during the event in the rodeo space.
6. Vendor will supply proper power cords subject to Fire Marshal Approval. Please bring a minimum of 200 ft.
7. Vendors will supply proper sanitary water hose, connections and check valves as needed.
8. Vendors will supply no less than two large refuse containers and empty to our dumpster as needed.
9. There will be no refund of booth fees. This event takes place rain or shine.
10. Vendor must be open for business at the start of activity and throughout the event and up to one hour after the event ends while crowds disburse.
11. Vendors must sell from their location only. No hawking or public address systems.
12. The \$150 fee must be paid with this application. We charge a flat fee for participation. This fee and form is due by August 1, 2008.
13. Overnight camping by permission only. Set up begins Friday before the event through Sunday morning. Must be up and running by 9am Sunday.
14. Consumption or promotion of alcoholic beverages, foul language, and violation of stated rules or other actions deemed inappropriate by the Helluva Rodeo or TMZ Farm will be cause for immediate removal from the premises and denial of future participation.
15. TMZ Farm, Helluva Rodeo and its sponsors, members, participants assume no liability for loss or damage to vendor's wares or property. Every reasonable precaution will be taken to guard against loss or damage, but the vendor hereby waives any claim for loss or damage to his/her property.
16. Helluva Rodeo does not make change, please come prepared.
17. The Rodeo Committee makes every effort to avoid overlapping in food vendors - meaning we will not allow similar vendors of similar items to participate in the day. 100% non overlap cannot be guaranteed.  
Helluva Rodeo 2008 had approximately 3000+ participants and spectators. Weather plays a big part of our event, plan accordingly. Heat - bring ice and drinks, cool weather - plan for more hot food and drinks. No guarantees can be made.
